# 5. Precept 2020 / 2021

Costs from previous years were studied and up coming costs were taken into consideration, before settling on a request freeze. Clerk advised that by changing to street lighting level 1 from 2 we would save on electricity costs, structural costs, Lumiere costs alone. Insurance was fixed for 5 years, so would only be a small increase to keep in line with national costs. Clerk also mentioned that in the annual return we have to give a reason as to why we have more than double the amount of the precept, and that we will still need to replace street lighting columns in the future, we should have enough as it is we have a freeze this precept. After discussion, all agreed to leave the precept amount at £3900. Precept form was completed and signed ready to send to ERYC by 17.01.20.
