Clerk has acquired three quotes ranging between £388 - £810 for bigger replacement. There are three choices of material Aluminium, wood, or recycled plastic. Aluminium is the less costly, wood being the costliest. All agreed that wood requires treatment, and that the other two materials do not, so the choices are between aluminium and recycled plastic. Due to costs all decided for the clerk to get colour options for powder coating on aluminium boards and go from there as plain aluminium will eventually oxidise and spoil. Earth Anchors was the quote that everyone chooses to proceed with and to request colour options before moving forward.
